We have audited the financial statements of Saline County Regional Solid Waste Management District (the "District") for the year ended December 31, 2024. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards and *Government Auditing Standards*, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated February 12, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Saline County Regional Solid Waste Management District are described in Note 1 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by Saline County Regional Solid Waste Management District during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate(s) affecting the District's financial statements was:

Management's estimate of the District's Net Pension Liability is based on APERS. We evaluated the methods, assumptions, and data used to develop the estimate in determining that it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was the retirement plan.

The disclosure of the retirement plan in Note 6 to the financial statements identifies the pension liability of the District.

The financial statement disclosures are neutral, consistent, and clear.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of

audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated June 17, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the District's financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as Saline County Regional Solid Waste Management District's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

We applied certain limited procedures to the Management's Discussion and Analysis, Schedule of the District's Proportionate Share of the Net Pension Liability and the Schedule of Contributions, which are required supplementary information (RSI) that supplements the basic financial statements. Our procedures consisted of inquiries of management regarding the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We did not audit the RSI and do not express an opinion or provide any assurance on the RSI.

We were engaged to report on the Schedule of Expenditures Comparison of Actual to Budget, which accompany the financial statements but are not RSI. With respect to this supplementary information, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with accounting principles generally accepted in the United States of America, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

Restriction on Use

This information is intended solely for the information and use of the Board of Directors and management of Saline County Regional Solid Waste Management District and is not intended to be, and should not be, used by anyone other than these specified parties.

Management's Discussion and Analysis

This section of Saline County Regional Solid Waste Management District's annual financial report presents an analysis of the District's financial performance for the year ending December 31, 2024. This information is presented in conjunction with the audited basic financial statements, which follow this section.

Financial Highlights for Fiscal Year

- The District's net position increased \$427,299 over the year from \$5,637,511 to \$6,064,810.
- The District's total unrestricted cash and investments increased \$185,250 over the past year from \$4,501,211 to \$4,686,471.

Overview of the Financial Statements

The annual report consists of the management's discussion and analysis and the basic financial statements. The financial statements include notes, which explain in detail some of the information included in the basic financial statements.

Required Financial Statements

The financial statements of the District report information utilizing the full accrual basis of accounting. The financial statements conform to accounting principles generally accepted in the United States. The balance sheet includes information on the District's assets and liabilities and provides information about the nature and amounts of investments in resources (assets) and the obligations to District creditors (liabilities). The statement of revenues, expenses, and change in net position identifies the District's revenues and expenses for the year ended December 31, 2024. This statement provides information on the District's operations over the past year and can be used to determine whether the District has recovered all of its costs through user fees and other charges. The third financial statement is the statement of cash flows. This statement provides information on the District's cash receipts, cash payments, and changes in cash resulting from operations, investments, and financing activities. From the statement of cash flows, the reader can obtain information on the source and use of cash and the change in the cash balance from the previous report.

Financial Analysis of the District

The balance sheet and statement of revenues, expenses, and change in net position provide an indication of the District's financial condition. The District's net position reflects the difference between assets and liabilities. An increase in net position over time typically indicates an improvement in financial condition. A summary of the District's balance sheet and statement of revenues, expenses, and change in net position are presented below.

As the above table indicates, total assets have increased \$387,184 or 6% over the past year from \$6,288,946 to \$6,676,130. This increase is primarily due to an increase in capital assets.

The total liabilities have decreased \$40,115 or 6% over the year from \$651,435 to \$611,320. This decrease is primarily from a decrease with the current liabilities.

The statements of revenues, expenses, and changes in net position identify the various revenue and expense items which affect the change in net position. As the table above indicates, the change in net position increased over the past year.

The District's operating revenue increased \$81,724 or 10% over the past year from \$786,513 to \$868,237. The increase is due to an increase in the grant revenue income during the year.

The District's operating expenses increased \$49,824 or 9% over the past year from \$544,052 to \$593,876. The increase is due to an increase in depreciation and wages and salaries.

The majority of the capital assets remaining are used in operations.

The only long-term debt of the District is the net pension liability. In a prior year, the District implemented GASB 68. With this implementation, the District now records its proportionate share of the net pension liability, deferred inflows and outlows of the pension plan administered by APERS, a multi-employer defined benefit plan in which the District participates. The net pension liability increased \$5,671 or 3% over the past year from \$196,407 to \$202,078.

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of Saline County Regional Solid Waste Management District which comprise the balance sheet as of December 31, 2024, and the related statements of revenues, expenses, and change in net position and cash flows for the year then ended and related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Saline County Regional Solid Waste Management District as of December 31, 2024, and the changes in its net position and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Saline County Regional Solid Waste Management District and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Such information is the responsibility of management and, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Other Information

Management is responsible for the other information included in the annual report. The other information comprises the Schedule of Expenditures – Comparison of Actual to Budget but does not include the basic financial statements and our auditors' report thereon. Our opinion on the basic financial statements do not cover the other information, and we do not express an opinion or any form of assurance thereon.

In connection with our audit of the basic financial statements, our responsibility is to read the other information and consider whether a material inconsistency exists between the other information and the basic financial statements, or the other information otherwise appears to be materially misstated. If,

based on the work performed, we conclude that an uncorrected material misstatement of the other information exists, we are required to describe it in our report.

Other Reporting Required by Government Auditing Standards

Note 1: Summary of Significant Accounting Policies

The Saline County Regional Solid Waste Management District (the District) is organized for the protection of the public health and the state's environmental quality through the development and maintenance of a solid waste plan for the people of Saline County. Operating income includes revenues and expenses related to the continuing operations of the District, including recycling. Principal operating revenues are royalties from the landfill and revenues from recycling. Principal operating expenses are the costs of providing services and include administrative expenses and depreciation of capital assets. Other revenues and expenses are classified as non-operating in the financial statements.

The District was created under Act 752 of the 78th Regular Session of the General Assembly of the State of Arkansas. The Board of Directors is composed of the Saline County judge and the mayors of the cities of Benton, Bryant, Alexander, Shannon Hills, and Haskell, Arkansas, or their appointed representative.

- A. **Basis of Presentation** The financial statements are prepared in accordance with generally accepted accounting principles (GAAP). The Governmental Accounting Standards Board (GASB) is responsible for establishing GAAP for state and local governments through its pronouncements (statements and interpretations).
- B. Basis of Accounting The financial statements are prepared on the accrual basis of accounting using the economic resources measurement focus. Revenues are recognized when they are earned and expenses are recognized when they are incurred.
- C. Cash and Investments Cash consists of all cash on hand, deposited in the bank, or in certificates of deposit. The District carries investments in marketable securities at their fair value on the balance sheet (see Note 3). The changes in unrealized gains and losses are included in investment return on the accompanying statement of revenues, expenses, and change in net position.
- D. Cash Deposits with Financial Institutions All cash deposited with banks is insured by the Federal Deposit Insurance Corporation. If the cash deposits exceed the \$250,000 federal deposit insurance limit, the financial institution has pledged government securities with a third-party custodian to cover the excess over the \$250,000 limit.
- E. Capital Assets Capital assets are recorded at cost. Any donated capital assets are recorded at fair value on the date of the gift. Depreciation is calculated using the straight-line method based upon the estimated useful lives of the related assets. Estimated useful lives are as follows, except for land, which is a non-depreciable capital asset:

Buildings 10-40 Years
Vehicles 5 Years
Equipment 3-15 Years

Maintenance and repairs are charged to expense as incurred. It is the District's policy for additions, renewals, and betterments with a cost of at least \$1,000 and a useful life of three years or longer to be capitalized.

F. **Grant Advances** – Funds received for the recycling grant are deferred and recognized over the period to which the recycling expenses are incurred.

Note 1: Summary of Significant Accounting Policies (cont'd)

- G. **Net Position** Under GASB 34, the District must report its net position as restricted, unrestricted, or invested in capital assets, net of related debt. As of December 31, 2024, the net position invested in capital assets, net of related debt was \$1,457,347. The remaining net position is reported as unrestricted.
- H. Use of Estimates The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 2: Restricted Funds

These are grant funds received from the Arkansas Department of Environmental Quality that have been restricted for the payment of e-waste & recycling expenses. The funds are held in a cash account and at December 31, 2024, had a balance of \$382,574.

Note 3: Investments

The District's investments consisted of government bonds and financial institution certificate of deposits, whose average time to maturity is 3 years. The investment policy of the District is to invest in publicly-traded fixed income securities and cash equivalents. A maximum of 25% of the portfolio may be invested in corporate bonds or commercial paper. All of the investments were insured up to their fair value. The following schedule summarizes the cost and fair value of these investments at December 31, 2024:

Note 6: Retirement Plan

Plan Description

The following brief description of the Arkansas Public Employees Retirement System (APERS) is provided for general information purposes only. Participants should refer to Arkansas Code Annotated, Title 24 for more complete information.

APERS is a cost-sharing, multiple-employer, defined benefit plan which covers all State employees who are not covered by another authorized plan. The plan was established by the authority of the Arkansas General Assembly with the passage of Act 177 of 1957. The costs of administering the plan are paid out of investment earnings. The general administration and responsibility for the proper operation of the System is vested in the nine members of the Board of Trustees of the Arkansas Public Employees Retirement System (the Board). Membership includes three state and three non-state employees, all appointed by the Governor, and three ex-officio trustees, including the Auditor of the State, the Treasurer of the State and the Director of the Department of Finance and Administration.

Benefits Provided

Benefit provisions are set forth in Arkansas Code Annotated, Title 24, Chapters 5 and 6 and may only be amended by the Arkansas General Assembly. APERS provides retirement, disability and death benefits. Members who began service prior to July 1, 2022 retirement benefits are determined as a percentage of the member's highest 3 year average compensation times the member's years of service. Members who began service on or after July 1, 2022 retirement benefits are determined as a percentage of the member's highest 5 year average compensation times the member's years of service. The percentage used is based upon whether a member is contributory or non-contributory as follows:

Contributory, prior to 7/1/2005 Contributory, on or after 7/1/2005,	2.07%
but prior to 7/1/2007	2.03%
Contributory on or after 7/1/2007	2.00%
Non-Contributory	1.72%

Members are eligible to retire with a full benefit under the following conditions:

- at age 65 with 5 years of service,
- at any age with 28 years actual service,
- at age 60 with 20 years of actual service if under the old contributory plan (prior to July 1, 2005),
- or at age 55 with 35 years of credited service for elected or public safety officials.

Members may retire with a reduced benefit at age 55 with at least 5 years of actual service at age 55 or at any age with 25 years of service.

Note 6: Retirement Plan (cont'd)

Members are eligible for disability benefits with 5 years of service. Disability benefits are computed as an age and service benefit, based on service and pay at disability. Death benefits are paid to a surviving spouse as if the member had 5 years of service and the monthly benefit is computed as if the member had retired and elected the Joint & 75% Survivor option. A cost-of living adjustment of 3% of the current benefit is added each year.

Contributions

Contribution requirements are set forth in Arkansas Code Annotated, Title 24, Chapter 4. The contributions are expected to be sufficient to finance the costs of benefits earned by members during the year and make a level payment that, if paid annually over a reasonable period of future years, will fully cover the unfunded costs of benefit commitments for services previously rendered (A.C.A. 24-2-701)(a)). Members who began service prior to July 1, 2005 are not required to make contributions to APERS. Members who began service on or after July 1, 2005 and before July 1, 2022 are required to contribute 5% of their salary. Members who began service on or after July 1, 2022 are required to contribute from 5% to 7%, in 0.25% increments, of their salary. Employers are required to contribute at a rate established by the Board of Trustees of APERS based on an actuary's determination of a rate required to fund the plan (A.C.A. 24-2-701(c)(3)). Employers contributed 15.32% of compensation for the fiscal year ended June 30, 2021.

Pension Liabilities, Pension Expense, and Deferred Outflows of Resources and Deferred Inflows of Resources to Pensions

The collective Net Pension Liability of \$2,914,186,544 was measured as of June 30, 2024, and the total pension liability used to calculate the Net Pension Liability was determined by an actuarial valuation as of that date. Each employer's proportion of the Net Pension Liability was based on the employer's share of contributions to the pension plan relative to the total contributions of all participating employers.

At December 31, 2024, the District reported deferred outflows of resources and deferred inflows of resources as of June 30, 2024, related to pensions from the following sources:

The long-term expected rate of return on pension plan investments was determined using a building-block method in which best-estimate ranges of expected future real rates of return are developed for each major asset class. These ranges are combined to produce the long-term expected rate of return by weighting the expected future real rates of return by the current asset allocation percentage and by adding expected inflation. Best estimates of arithmetic real rates of return for each major asset class included in APERS' target asset allocation as of June 30, 2024 are summarized in the table below:

Discount Rate

A single discount rate of 7.00% was used to measure the total pension liability. This single discount rate was based on the expected rate of return on pension plan investments of 7.00%. The projection of cash flows used to determine this single discount rate assumed that plan member contributions will be made at the current contribution rate and that employer contributions will be made at rates equal to the difference between actuarially determined contribution rates and the member rate. Based on these assumptions, the pension plan's fiduciary net position was projected to be available to make all projected future benefit payments of current plan members. Therefore, the long-term expected rate of return on pension plan investments was applied to all periods of projected benefit payments to determine the total pension liability.

Sensitivity of the Proportionate Share of the Net Pension Liability to Changes in the Discount Rate

The following presents the proportionate share of the Net Pension Liability using the discount rate of 7.00%, as well as what the Net Pension Liability would be if it were calculated using a discount rate that is 1-percentage-point lower (6.00%) or 1-percentage-point higher (8.00%) than the current rate:

Independent Auditors' Report on Internal Control over Financial Reporting and on Compliance and Other Matters Based on an Audit of Financial Statements

Performed in Accordance with Government Auditing Standards

Board of Directors Saline County Regional Solid Waste Management District Benton, Arkansas

We have audited, in accordance with the auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards* issued by the Comptroller General of the United States, the financial statements of Saline County Regional Solid Waste Management District (an independent governmental unit), which comprise the balance sheet as of December 31, 2024, and the related statements of revenues, expenses, and change in net position and cash flows for the year then ended, and the related notes to the financial statements, and have issued our report thereon dated June 17, 2025.

Report on Internal Control over Financial Reporting

In planning and performing our audit of the financial statements, we considered Saline County Regional Solid Waste Management District's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of Saline County Regional Solid Waste Management District's internal control. Accordingly, we do not express an opinion on the effectiveness of Saline County Regional Solid Waste Management District's internal control.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected on a timely basis. A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.
